This anti-stigma video is depicted from the students' point of view. A title still needs to be chosen and credits added at the end of the video. After viewing the video, the council commented on how very powerful it was. They would like to use it for future events, the Summit and for the Public Health website. They also discussed the possibility of presenting an award or scholarship. The video ran 13 minutes. It flowed very well and the layout was great. The students did a great job! Suggestions by the Council included: • Look at submitting for an award. Probably will need to block out last names of students at end of video for confidentiality, security and safety reasons. • Slow the written dialogue down for slow readers. • Look at legal ramifications. Do they need parents to sign releases? The students did sign a release. • Use the video at the Mental Health Summit, area high schools and community organizations, such as the Lions Club, Rotary and Kiwanis. • Have a video contest among area high schools and give an award. • Submit to Mental Health America to put on their website. Student Survey Results and Fall 2014 plans – Char	100% of the surveys received were from Rhinelander High School. Unfortunately, there were only 10 responses. The timing of the survey was bad. It was found the end of the school year was not a good time to distribute. We will need to do again after the school year starts. The number of responses was too low to draw any conclusions but one question did stand out. 75% of the students surveyed said they did not feel resources on mental health have been made available or have been provided to them. When asked where they preferred to get their information on mental illnesses, the majority responded teachers, nurses and doctors rather than social media, friends or parents.
